## Introduction

EIB-IR-Control replaces nearly all tele pilots for consumer electronics like TV, SAT, Video with only one unit. One telepilot is usable to control all EIB actors. Switching, dimming, temperature adjustment and shutters. One IR-controller supports up to 8 IR-sensors.

In teach in mode, you can copy the complete functions of consumer telepilots used for TV-, Video- und SAT. Functions of most of all manufacturers are already integrated. So you can omit tech in. Just click to a device and import all functions.

Programming of EIB-functions is easily done by typing in the group address, EIS-Type and function.

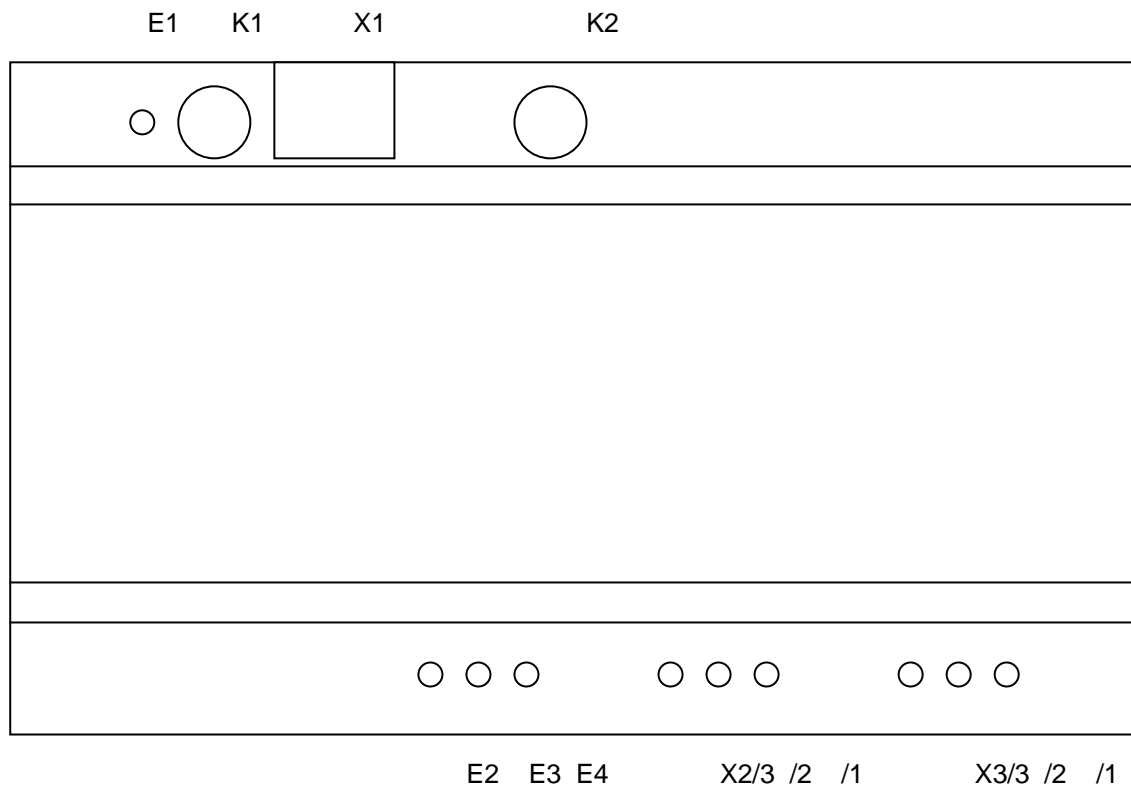

## ETS Parametrization

The EIB-IR-controller needs only a physical address.

To select a physical address, just select a BCU1-bus coupler in the ETS (for example serial bus coupler or universal bus coupler for timers).



## Parametrization software for telepilot

Part of delivery of the telepilot is a version of the original parametrization software of the manufacturer. But also newer version of that manufacturer software can be used.

In addition, part of delivery is the software „IRGEN“ to parametrize the group addresses, EIS-types and values.

## Installation of IRGen

1. Start the program prontoedit2\_0.exe in the directory d:\eib ir fb\prontoedit\ (if „d“ is your CD-rom drive). Take attention to the instructions of the manufacturers installation program.
2. Copy prontoini.exe into the same directory as the ProntoEdit.
3. Start Prontoini.exe and set „developer mode“.
4. Copy the files "IRGEN.EXE", "IRGENKEY.DLL" and "IRGEN.INI" from d:\eib ir fb\irgen\ into the directory of ProntoEdit.

Steps 1 – 3 are only needed if you have no other version of the manufacturer's software tool.

## Options

If you want to use 2-step group addresses, set "GADual" in "IRGEN.INI" to "1". Use a standard text editor.

## Using IRGen

You have to enter the group address in the upper part of the window. In the next field you have to select the EIS type of the address. In the last input field you have to enter the value you want to write to the address. If you want the value to be written repeatedly until the user is releasing the button on the IR control, you have to enable the "telegram repetition" option.



For example:

If you want to write the value "1" to the binary address "0/0/1", you have to enter the following values:

Groupaddress: "0/0/1"  
EIS type: "0010: Switch"  
Value: "1"  
Telegram rep.: "No"

After you have defined the desired telegram, simply press the "Std. Pronto: Create IR code" button. In case you are using a Pronto NG remote control, press the button "Pronto NG: Create IR code" instead.

Now the ProntoEdit code will be displayed and automatically send to the clipboard as well.

Now you can use the ProntoEdit application to set the new code to a control button (double-clicking the button, etc.), if you are using the V2 version of the ProntoEdit software you can also try the automatic <F5> mode: move you mouse cursor over the ProntoEdit button, and hit the <F5> key. Now the IRGen software will try to do all necessary steps to enter the displayed IR code into the button properties.

Please note: if you have a different version of the ProntoEDIT software, this automatic import may fail. In such a case you have to use the Windows clipboard to copy/paste the IR code definition.

After you have parametrized all the ProntoEdit buttons/controls you want to use, you can download your project to the remote control.
